
# A Tale of Two Recoveries

How Deutsche Bank, Ocwen Financial, and Altisource Failed to Maintain Its Bank-Owned Homes in African American and Latino Neighborhoods in the Greater Palm Beaches, FL Area.



### Overview: Maintenance Investigation of Bank-Owned Homes

- This PowerPoint reflects the investigation by the **Fair Housing Center of the Greater Palm Beaches** over 3 years from 2014-2016.
- Banks claim to preserve and maintain their properties to the same standard of maintenance as is found in the neighborhood. NFHA and partners took photos of the bank-owned homes and neighboring homes to put into context how Deutsche Bank, Ocwen, and Altisource failed to maintain their properties in African American and Latino neighborhoods across the country.
- These investigations are about routine maintenance on the outside of the bank-owned homes. Banks are paid to mow lawns, remove trash/debris left by the previous owner or litterer, and secure doors and windows to thwart vandalism and squatters.
- Boarded doors and windows, overgrown grass, invasive plants, and trash and debris on the property detract from the home's curb appeal to owner-occupant buyers.

## Methodology for Investigation



- For every bank-owned home, there were 39 maintenance or marketing factors evaluated on a checklist.
- The investigator simply marked "yes" or "no" as to whether the deficiency was present at the property.
  - For example, 1 broken window would count as 1 deficiency; likewise, 3 broken windows would count as 1 deficiency.
- Photos were taken of the bank-owned home and neighbors on both sides and across the street.

### Methodology for Investigation

#### **Curb Appeal**

 Trash, Leaves, Overgrown Grass, Overgrown Shrubs, Invasive Plants, Dead Grass

#### Structure

 Broken Windows, Broken Doors, Damaged Fences, Damaged Roof, Holes, Wood Rot

#### Signage

 Trespassing/warning signs, "Bank owned", "Auction", or "Foreclosure" signs, "For Sale" signs missing or broken/discarded



### Methodology for Investigation

#### **Paint/Siding**

 Graffiti, excessive peeling/chipped paint, damaged siding

#### **Gutters**

 Missing, out of place, broken, hanging, obstructed

#### Water Damage

 Mold, discoloration, excessive rust, erosion

#### Utilities

 Tampered with or exposed


### Investigation

- A total of **41** Deutsche Bank properties were evaluated in the Greater Palm Beaches, FL metro area
  - 1 Deutsche Bank property was located in a predominantly African-American community
  - 11 Deutsche Bank properties were located in predominantly Latino communities
  - 9 Deutsche Bank properties were located in a community with a majority of non-White residents
  - 20 Deutsche Bank properties were located in predominantly White communities.



### **Greater Palm Beaches, FL Racial Disparities**

- 81.1% of Deutsche Bank properties in communities of color had trash or debris on the premises, while only 25.0% of properties in White communities had the same problem.
- 61.9% of Deutsche Bank properties in communities of color had overgrown or dead shrubbery, while only 45.0% of properties in White communities had the same problem.
- 52.4% of Deutsche Bank properties in communities of color had unsecured or boarded doors, while only 30.0% of properties in White communities had the same problem.
- 61.9% of Deutsche Bank properties in communities of color had broken or boarded windows, while only 20.0% of properties in White communities had the same problem.



#### 61.9% of Deutsche Bank properties in Communities of Color Had Trash or Debris




## 81.1% of Deutsche Bank properties in Communities of Color Had Overgrown or Dead Shrubbery






From the front yard we can see Deutsche Bank's neglect, and it only gets worse as we go around to the side and back...






## The side of the home is overgrown with piles of trash on the concrete.

#### The backyard is also completely overgrown, with more trash.






## This Deutsche Bank home has a busted-out window as well as an unsecured shed.







Here are the wellmaintained neighbors who have to live next to Deutsche Bank's overgrown and unsecured property.


Their yards are free of trash and debris unlike Deutsche Bank.

#### More dead shrubbery, leaves, and trash.






In addition to trash, this gutter is missing a downspout and is allowing water to run straight into the home's foundation.


