### Position Summary:

The Data Engineer will work on the Tech Equity team and may work cross-functionally with the enforcement team, policy team, data scientists, and application developers to architect and implement data solutions that drive the operations of The National Fair Housing Alliance's (NFHA) Tech Equity Initiative objectives and overall goals.

### Responsibilities:

- Develop, automate, and support scalable data pipelines and build new integrations to support increasing data volume.
  - Design and build data service APIs and expose data to end-users using (custom) visualization tools.
  - Ensure ingestion and delivery of data for upstream processing by Data Scientists and other decision makers.
  - Build resilient data pipelines and contribute to other internal development works.
  - Support the planning and implementation of data platform services, including configuration and needs assessment.
  - Design metrics and dashboards to monitor data processes and data quality.
  - Implement data masking and encrypt data at rest and in motion.

- Experience with Agile Software Development methodologies
