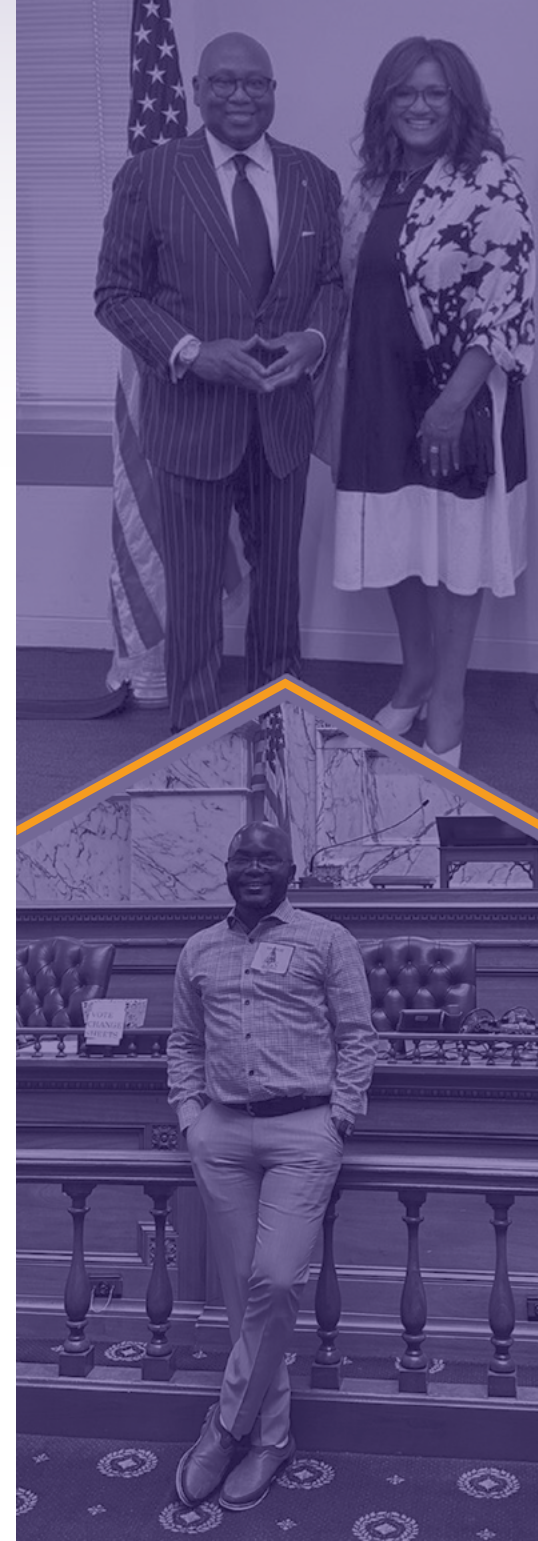

ABOUT NFHA

Letter from our President & CEO

Dear Fair Housing Advocates, Supporters, and Friends,
Nearly six decades ago, the Fair Housing Act was enacted with a clear and powerful purpose: to eliminate housing discrimination and ensure that every person—regardless of race, color, national origin, religion, sex, disability, or family status—has equal access to housing opportunities. This principle is at the heart of attaining the American Dream, and it remains the foundation of the National Fair Housing Alliance’s mission.

Over the past year, the fair housing movement has faced significant challenges. One of the most pressing was the suspension of critical federal grants that provide essential support to NFHA’s network of more than 170 community-based organizations across the country, enabling them to advance fair housing enforcement and education. These grants are not just line items—they are lifelines for disabled veterans, families with children, survivors of abuse, and people simply trying to maintain stable housing free from discrimination. When these grants were rescinded, threatening the very existence of our member agencies on the front lines, we didn’t retreat. We fought back—and won.

NFHA stepped forward to lead during this pivotal moment. We mobilized, educated, and worked tirelessly to ensure the movement carried on. From the courtroom to the halls of Congress we fought to protect the rule of law, advanced our vision of fair and affordable housing for all communities, and championed civil rights protections in artificial intelligence.

Key victories include:

- Settling a systemic accessibility case that expanded housing opportunities for 1.3 million people with disabilities
- Securing reinstatement of Fair Housing Initiatives Program (FHIP) funding through litigation, defending fair housing programs nationwide
- Resolving a major accessibility case impacting 5,000 housing units in partnership with the Tennessee Fair Housing Council
- Hosting our second annual Responsible AI Symposium, convening policy makers, technologists, fair housing advocates, and industry to shape the future of AI that works for all of us

These victories underscore what is possible when we stand firm in our resolve and unite for justice and equity. Yet, our work is far from finished. Discrimination in housing remains both pervasive and persistent, and housing affordability remains the number one issue for too many families in our country. That is why we invite you—our partners, supporters, and allies—to join us in this fight. Together, we can advance policies, challenge inequities, and create pathways for everyone to achieve the American Dream. Together, we can keep doors open.

Thank you for standing with us. Your commitment fuels our mission and strengthens our efforts to build a nation where fair and affordable housing opportunities are not just a promise, but a reality for all.

NFHA's Vision

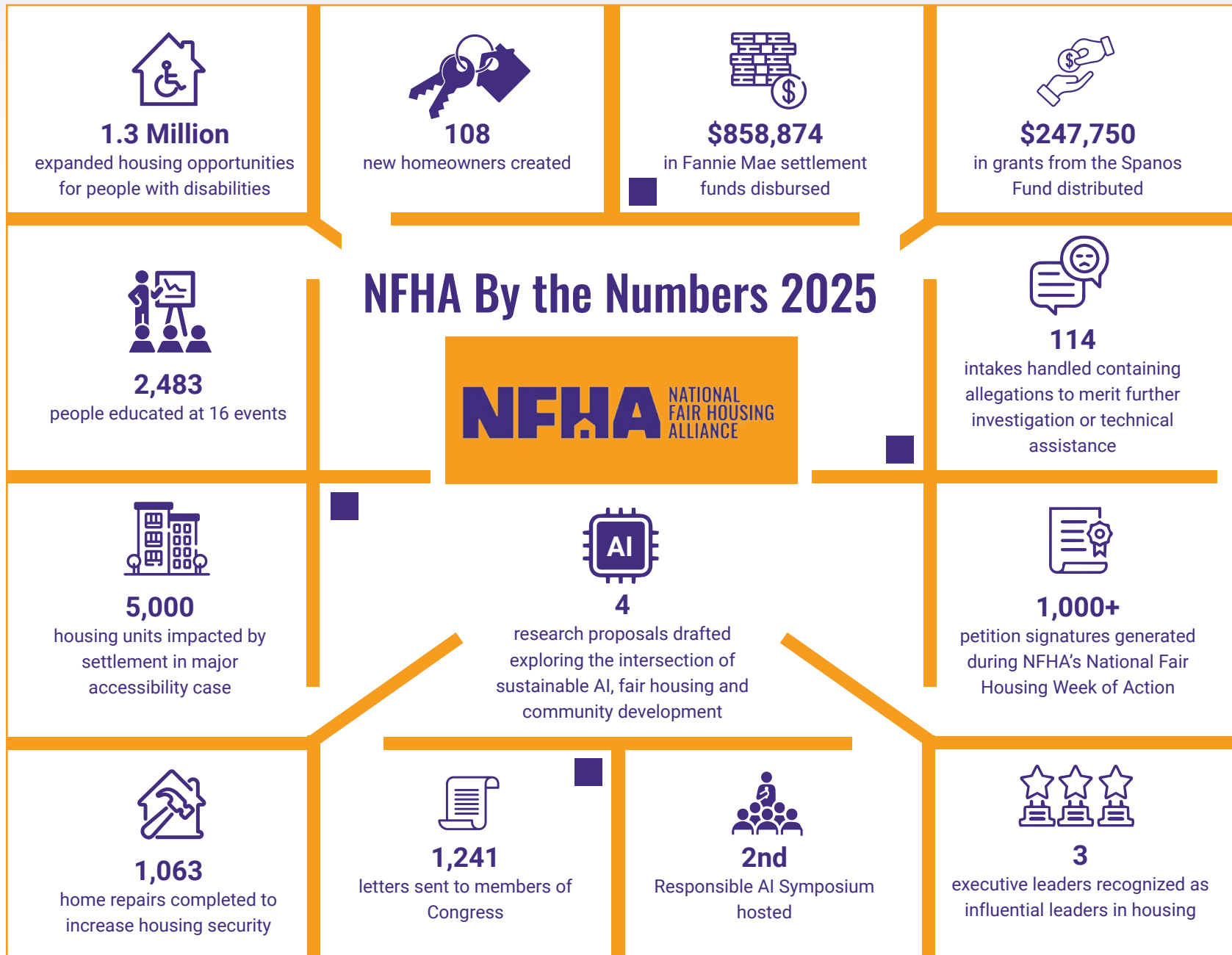
Communities are healthy, resilient, well-resourced, and free from discrimination so that everyone has the resources they need to thrive.

Defending Fair Housing: Our Commitment to Justice

At the heart of our mission is the unwavering belief that every person deserves equal access to housing free from discrimination. Throughout the year, we worked tirelessly to protect and enforce the principles of the Fair Housing Act—challenging systemic barriers, holding violators accountable, and advocating for policies that promote equity and inclusion. Our efforts ensure that families across the nation can pursue the American Dream without fear of bias or exclusion.

- NFHA's National Fair Housing Week of Action mobilization efforts generated over 1,000 signatures—with 41,000+ petition views and 300 people sharing the petition.
- Settled major accessibility case impacting 5,000 rental housing units in connection with the Tennessee Fair Housing Council
- NFHA led the development and filing of two lawsuits in defense of the Fair Housing Initiatives Program.

Enforcing Fair Housing: Turning Principles into Action

Ensuring fair housing is not just about advancing the law—it's about making sure the law is followed. Our enforcement work focuses on investigating discrimination, pursuing legal action against violators, and ensuring favorable outcomes for the communities we serve. Through strategic litigation, complaint resolution, and collaboration with local partners, we safeguard the rights of individuals and families, ensuring that the protections promised by the Fair Housing Act are upheld in every community.



OUR IMPACT

Supporting Our Members: Strengthening the Movement

Our members are the backbone of the fair housing movement, and we are committed to providing the tools, resources, and guidance they need to serve and succeed. From training and technical assistance to advocacy support and networking opportunities, we empower our partners to advance equity in their communities. By investing in our members, we amplify their impact and ensure that together, we can dismantle barriers to fair and affordable housing across our nation.

- Activated weekly meetings with community-based fair housing non-profits whose grants were terminated.
- Provided enforcement and investigation guidance during our virtual member In-Service training.
- Facilitated increased member-to-member dialogue to share learnings and best practices to navigate the changing landscape under a new administration.
- Hosted webinars with industry leaders to bring our members closer to the experts.



Leading the Way Forward: Driving Innovation and Equity

As the nation faces evolving challenges in housing access and affordability, NFHA continues to lead with vision and moral clarity. We are shaping the future of fair housing through bold advocacy, innovative programs, and strategic partnerships that break down systemic barriers. By anticipating emerging issues and championing solutions, we ensure that progress is not only sustained but accelerated—creating pathways for every person in our country to attain, and maintain, housing free from discrimination.

NFHA successfully hosted its second annual Responsible AI Symposium featuring our first ever AI Pitch Competition. The competition drew ambitious AI startup founders from across the country; all rooted in the principle of aligning civil and human rights with emerging technologies. For 71% of attendees this was the first NFHA event they had attended. 100% of participants were very satisfied or satisfied with the Symposium, and 82% were very likely to attend future NFHA events.

- Released NFHA's first annual State of Equitable Homeownership Report highlighting modest homeownership gains for people of all races based on NFHA's advocacy leadership and community development initiatives.
- Secured a substantial consulting contract with a major insurer for a 3-year training program on auditing algorithmic models.

SUCCESS STORIES



This homebuyer is among 15 recipients of down payment assistance grants funded through **NFHA's Fannie Mae settlement** allocation in Charleston, SC. The initiative was made possible through NFHA's collaboration with the Charleston Urban League's First-Time Homebuyer Program.

These are the participants in **Pennsylvania Horticultural Society's** workforce development program. Sixteen people from the Philadelphia neighborhood of Tioga-Nicetown with barriers to employment were trained and placed into full-time jobs with employer partners.



SUCCESS STORIES



Larry Vandiver, a lifelong Memphian and one of the first participants in the Klondike IDA program, joined with a dream of becoming a homeowner. Through the program, he gained the financial tools, support, and matched savings needed to purchase a Klondike Community Land Trust (CLT) home. His journey didn't end there. After closing on his home, Larry became a passionate ambassador for the program, referring his sister and niece, who both went on to purchase their own CLT homes. His story illustrates the powerful ripple effect a single investment in equitable housing can create—not just for one person, but for an entire family.

Candice Vance, a longtime tenant leader in North Minneapolis, purchased her home through the City of Lakes Community Land Trust with help from NFHA's Inclusive Communities funding. The support covered mortgage payments during a family health crisis and allowed her to make essential repairs—painting walls, installing cabinets, and putting in new kitchen flooring. In February 2024, Candice closed on her home with payments lower than pre-2009 mortgage rates. This core tenant leader who fought both systemic disparities and direct discrimination in housing received due compensation and ultimately, justice.

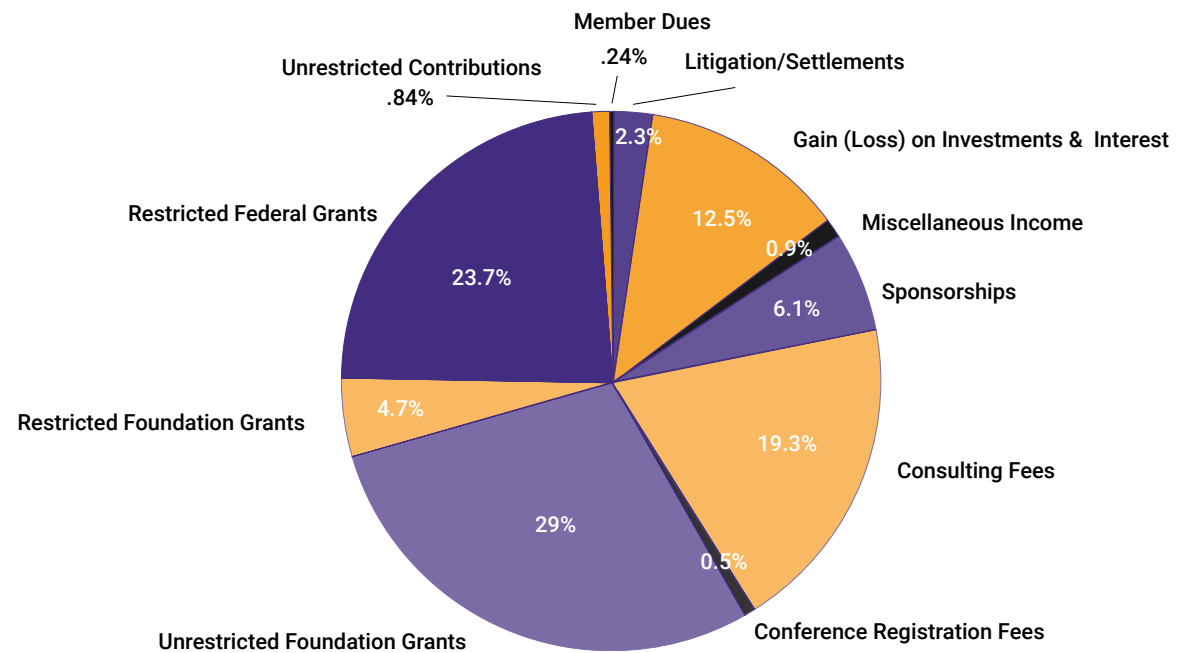
